To reduce barriers, One Roof provides youth in the KFL&A area with access to support and services in one location (620 Princess St, Kingston).  The Intensive Community Crime Prevention (ICCP) program supports youth between ages 16-24 in conflict with the law. ICCP will engage youth with the highest needs – particularly those individuals who are unwilling or unable to access other community treatment programs.	L. Larock
